


Texas Capital Government Money Market Fund

Quarterly Fund Fact Sheet As of 12/31/2024

FUND OBJECTIVE & STRATEGY

The Texas Capital Government Money Market Fund (the "Fund") seeks to provide as high a level of current interest income as is consistent with maintaining liquidity and stability of principal. The Fund is a government money market fund that invests 99.5% of the fund's total assets in cash, U.S. government securities, which may include fixed, floating and variable rate securities, as well as repurchase agreements collateralized fully by U.S. government securities or cash. The Fund seeks to maintain a stable \$1 share price and will comply with SEC rules applicable to all money market funds, including Rule 2a-7 under the Investment Company Act of 1940.





GLOSSARY/DEFINITIONS

Net Asset Value (NAV) The market value of a mutual fund or ETFs total assets, minus liabilities, divided by the number of shares outstanding.

Gross Expense Ratio The Fund's total annual operating expense ratio. It is gross of any fee waivers or expense reimbursements. It can be found in the Fund's most recent prospectus. **FTSE 1-3 Month US T-Bill** The FTSE 3 Month US T-Bill Index Series is intended to track the daily performance of 1-3-month US Treasury bills.

Weighted Average Maturity (WAM) The money market fund's weighted average maturity (WAM) is an average of the effective maturities of all securities held in the portfolio, weighted by each security's percentage of net assets.

Weighted Average Life (WAL) The money market fund's weighted average life (WAL) is an average of the final maturities of all securities held in the portfolio, weighted by each security's percentage of net assets.

U.S. Government Securities Risk: There are different types of U.S. government securities with different levels of credit risk, including the risk of default, depending on the nature of the particular government support for that security. For example, a U.S. government-sponsored entity, such as Federal National Mortgage Association ("Fannie Mae") or Federal Home Loan Mortgage Corporation ("Freddie Mac"), although chartered or sponsored by an Act of Congress, may issue securities that are neither insured nor guaranteed by the U.S. Treasury and are therefore riskier than those that are.
